Who Can Get This Money?

FAMILIES RECEIVING CALWORKS AND FAMILIES WHO RECENTLY WENT OFF CALWORKS DUE TO TIME LIMITS.

YOU MAY QUALIFY IF:

- YOU RECENTLY LOST YOUR JOB.
- YOUR INCOME WENT DOWN OR STOPPED.
- YOUR RENT WENT UP.
- YOU HAVE MEDICAL EXPENSES NOT PAID BY MEDI-CAL OR INSURANCE.
- YOU HAD AN UNEXPECTED EMERGENCY, SUCH AS FUNERAL COSTS (FOR A SPOUSE OR CHILD) OR CAR REPAIRS.
- YOU WERE A VICTIM OF A CRIME.

REMINDER - YOU MUST REPORT ON YOUR QUARTERLY REPORT (QR 7) ALL INCOME THAT YOU OR ANYONE IN YOUR HOME GETS-EVEN IF YOU OR THEY DO NOT GET CASH AID.



OTHER THINGS YOU NEED TO KNOW

- YOUR RENT CANNOT BE MORE THAT 80% OF THE MAXIMUM CALWORKS GRANT (MAP) FOR A FAMILY OF YOUR SIZE. FOR EXAMPLE, IF YOU ARE A FAMILY OF 3, YOUR RENT LIMIT WILL BE \$563, WHICH IS 80% OF YOUR \$704 MAP.

YOU MUST PROVIDE :

- PROOF THAT YOU OWE YOUR LANDLORD FOR LAST MONTH'S RENT AND SECURITY DEPOSIT. (THE OWNERSHIP INFORMATION OF THE HOUSE/APARTMENT WHERE YOU PLAN TO MOVE WILL BE VERIFIED.)
- PROOF THAT YOU OWE MONEY TO TURN ON YOUR LIGHTS, GAS, WATER, AND/OR PHONE.
- PROOF THAT YOU PROVIDE WILL BE VERIFIED BY THE DEPARTMENT OF PUBLIC SOCIAL SERVICES (DPSS) WITH YOUR LANDLORD, UTILITY COMPANY OR OTHER SOURCES.
- ESTIMATES FOR MOVING EXPENSES, SUCH AS RENTAL OF A TRUCK.
- ESTIMATES IF YOU NEED A STOVE/REFRIGERATOR, BECAUSE YOUR NEW HOUSE/APARTMENT DOES NOT HAVE THEM.
